Explanation of Responses:

- On October 22, 2012, the issuer granted to the reporting person 19,500 shares of fully-vested restricted stock (the "Additional Shares") pursuant to a tax assistance program being offered in connection with an option exchange program (the "Program"). On November 19, 2012, the issuer repurchased from the reporting person 9,299 of the Additional Shares to fund tax withholdings in connection with the Program and the reporting person forfeited the remaining 10,201 Additional Shares pursuant to the Program.
- The cancelled options provided for vesting in four equal annual installments beginning on May 19, 2012.
- On November 19, 2012, the issuer cancelled, pursuant to the Program, options granted to the reporting person on May 19, 2011. In exchange for these options, the reporting person retained a replacement share award of restricted stock, which was granted on October 22, 2012 and was reported on a Form 4 filed by the reporting person on October 24, 2012.
