Explanation of Responses:

- The reported transaction was made pursuant to a Rule 10b5-1 plan adopted on May 4, 2015.
- Reflects the purchase of 2,000 shares of Class A Common Stock at the weighted average purchase price of \$6.23. The prices for these shares range from \$6.20 to \$6.34.
- Includes 550,000 restricted shares of Class A Common Stock, of which 100,000 vest in equal installments on October 15, 2016 and October 15, 2017, 100,000 vest in equal installments on December 31, 2017 and December 31, 2018, and 350,000 are subject to performance vesting (none of which have vested as of the date of this report).
- The reported item represents shares of Class A Common Stock beneficially owned by Pittman CC, LLC, a limited liability company controlled by the Reporting Person. The Reporting Person disclaims beneficial ownership of such shares except to the extent of his pecuniary interest therein.
